Financial Report

Summer camp net proceeds were \$2639.58. Tax year is July 1-June 30. Balance as of August 31: \$10,051.78

Funding Overview

- Prior to summer camp we had \$5000
- We are receiving \$10,000 from the Young Sheldon Grant
 - o \$2500 can be spent on registration fees
 - We have limitations on what we can purchase.
- The district will pay for a bus for state and a bus for worlds from Jennifer Adams' budget.

- Our district buses may be covered by UIL, but the booster would cover the box truck that must be rented through the district.
- Students will send quotes and carts to Rebecca Jones and Jennifer Adams, and equipment must be funneled through the campus funds except in an emergency.
- Teachers are requesting a meeting with Dr. Bailey to discuss rules that work uniquely for our group.
- We can have supplies on hand if they are meant to be used this year.
- We must spend half of the grant money before December, and the game isn't released until January. Students need to choose items that will help with building in general.
- Booster club can donate items with a donation form.
- Booster can donate to school account, but school cannot donate to the booster.
- First in Texas grants must be spent on registration. Mark is estimating we should get \$1000 from First that can go towards registration.
- School cash online has been set up for club dues. Once members are accepted, teachers will email the link \$47 includes one shirt or \$62 if you want two shirts. These dues include consumables, training supplies, etc.

We owe the school activity fund about \$150, so Ms. Coronado suggested donating \$750 to the school to be used for the competition and covering last year's overage.
